## 2018 Surf Rodeo - Vendor Application

Thank you for your interest in participating as a Vendor at the 2018 Surf Rodeo! This is the 11th year of the festival and we are looking forward to another great year of music, surfing, bikini cowgirls, corn hole, bull riding, beach games and much more.

The 2018 application deadline to be considered for a Vendor booth is **June 1, 2018**. However we typically sell out prior to this date. Applications received after June 1st but before July 1st, may still be considered if space is available. The selection committee will review all early applications and selected vendors will be notified and invoiced for the booth fee. Late applicants (received after June 1st) will be reviewed as they are received, and as spaces allow.

### 2018 Vendor Booth Fees-

**Regular 10x10 Booth Space (2 day) \$495/\$525 Space is first come first serve. This event does sell out.**

Please keep in mind the following:

- (1) Vendor provides own booth, chairs, tables, tie downs etc., the Festival provides a 10'x10' space. Booths are on asphalt so no use of ground stakes, please bring proper weights/sandbags required to ensure everyone's safety.
- (2) No electricity will be provided in this area.
- (3) All booth spaces are corner spaces allowing vendors 2 sides to sell from.
- (4) Descriptions of all items being sold are required and must be submitted with this application. Incomplete applications will not be considered by the selection committee.
- (5) Surf Rodeo LLC reserves the right to reject any application. Past participation in the festival does not guarantee acceptance into the 2018 festival and booth placement is at the sole discretion of the festival organizers.
- (6) Waste Disposal - It is the responsibility of all vendors to remove from the Festival all cardboard and plastic packaging, master carton and packing materials used to transport your merchandise that you offer for sale at the festival. We encourage all vendors to recycle or reused these materials when possible.
- (7) Vending hours are as follows:  
Saturday, July 14th 10am – 8pm  
Sunday, July 15th 10am – 7pm

8) Booth Fees are non-refundable for any reason unless your application is denied. As an outdoor festival, please understand that we are at the mercy of Mother Nature.

9) No food or beverages may be sold, given away or distributed at vendor booths other than those specifically identified as food vendors.

10) Hold Harmless: By signing this form you affirm and agree to hold harmless Surf Rodeo LLC, its directors, officers, employees, agents and assigns from any and all loss, claim, action, suit or liability to third persons (including attorney fees at trial and appeal), from any cause whether directly or indirectly related to this event or this agreement including but not limited to claims for injury to persons including death or destruction of property; whether intentional, negligent or consequential as result of any act or omission of yours, or the officers, directors, employees or agents of your business.
